## **RE: 2018-2019 Student Accident Excess Coverage Information for PreK-12**

As the 2018-2019 school year begins, we want to remind you that all ISDA members must have Student Accident Excess Coverage, which is available from sources including the ISDA. The ISDA Student Accident Coverage provides that medical expenses are covered up to the limit of \$5,000,000 per eligible student or the expiration of the ten (10) year benefit period, whichever occurs first. This coverage includes injuries for football excess of \$25,000 out-of-pocket expense. The ISDA program now covers PreK-12. ISDA will mail a Student Accident Certificate of Coverage to each district that purchases the Student Accident Coverage, and if applicable, will provide evidence of coverage to the Illinois High School Association.


Please notify parents prior to the first day of the 2018-2019 school year that this coverage is available. An electronic version of the brochure and claim kit is available by accessing the student accident links at [www.wcsit-isda.com](http://www.wcsit-isda.com). Please feel to put this brochure on your website. Parents should refer to the Student Accident Coverage brochure (which should be available in the District's office or on the District's website) as a summary of coverage. An identification card is included in the brochure, and the card should be presented to medical/dental providers, along with their primary insurance ID card, whenever medical attention is sought for a school related injury.

### **Filing a Claim**

In the event of a school related injury, the parent must first file a claim with their own health insurance. The parent should then file a claim under the ISDA Student Accident Coverage by providing notice to the ISDA Claims Administrator and submitting a Claim Form after the school completes their portion (available in the District's office). Claims must be submitted using the Claim Form for the current program year (2018-2019) only, and must be reported within 90 days of the date of injury.
